PBC – Multi-Agency GEPC Program

Program Structure

- Increase Energy Efficiency In a Wide Variety of Public Buildings
- Utilize ESCOs to Identify, Install, & Guarantee Energy-Related Capital Improvements
- Administered by the PBC on Behalf of User Agencies

PBC – MAGEPC Program

Primary Goals

- Reduce energy costs without incurring upfront capital costs
- Guaranteed Energy Consumption Reductions (estimated between 18% and 28% annually)
- Utilize (ECM) retrofits that achieve significant long term savings that can be measured and verified.
- ESCOs guarantee annual savings will be more than sufficient to cover Program financing costs

PBC – MAGEPC Program

Program Objectives

- Create Local Jobs
- Reduce Greenhouse Gas Emissions
- Obtain Improved Levels of Occupant Comfort & System Functionality.
- Enhance the capacity to centrally monitor and remotely manage public buildings
- Lower every building's lifetime operating cost

Current Program

- City Department of General Services
 - 45 buildings (variety of functions: fire, police, library, office, garage)
 - Current annual utility costs of \$6.5 million
 - Estimated energy reductions of between \$1.2 million and \$1.8 million per year.
 - Cost estimate for ECM implementation \$20 million
- Chicago Public Schools
 - 23 schools (16 elementary schools, 7 high schools)
 - Current annual utility costs of \$3.8 million
 - Estimated energy reductions of approximately \$900,000 per year
 - Cost estimate for ECM implementation \$13.4 million

 - CAV to VAV conversions

- Building Envelope & Roofing Renovations

- Significant reduction of the lifetime operating costs
- Local jobs created
- PBC Project Participation Guidelines followed

- Utilize minority business enterprises (MBEs) for not less that 24% of the value of the work and services under the GEPC;
- Utilize women business enterprises (WBEs) for not less than 4% of the value of the work and services under the GEPC;

- Utilize local businesses for subcontracting work in accordance with the following guidelines:
 - i. ESCOs that are local businesses (as defined in clause (iii) below) are required to award 25% of the value of the work and services under the GEPC to subcontractors that are local businesses.
 - ii. ESCOs that are not local businesses (as defined in clause (iii) below) are required to award 35% of the value of the work and services under the GEPC to subcontractors that are local businesses.
 - iii. A "local business" is one that: 1) owns or leases a functioning business office and/or operations facilities within the City of Chicago; 2) is registered and licensed to do business in the City of Chicago; 3) employs City of Chicago residents; and 4) is subject to City of Chicago taxes.

- Utilize local residents for not less than 50% of the total labor hours under the GEPC.
- Provide opportunities for employment of community residents.



M/WBE Networking Session-for the PBC Multi Agency Guaranteed Energy Performance Contracting Services

- Provide opportunities for employment for the following programs:
 - a. Federally funded State Energy Sector Partnership Program administered by the Chicago Workforce Investment Council. Program partners include but are not limited to;
 - i. HACIA (Hispanic American Construction Industry Association)
 - ii. CWIT (Chicago Women in Trades)
 - iii. Chicago Regional Council of Carpenters Apprentice and Training Program
 - b. Persons who have completed or are enrolled in programs comparable to the City Colleges of Chicago's Building Energy Technologies Occupational Certificate program at Wilbur College.
