ITEM NO. 4: REQUESTS FOR INFORMATION

1. **Question/Statement:** Specification Section 12 21 13 Horizontal Louver Blinds states to provide a blind at each window within the Administrative Offices unless noted otherwise. Drawing A1.1 shows new window shades being installed in the Principal and Counselor Offices, not louver blinds. Is the drawing correct and are we to provide roller shades at these locations not louver blinds? Please clarify locations for Horizontal Louver Blinds specified in Section 12 21 13.

Response: Horizontal blinds are to be installed in Principal Office #141, Counselor Office #142 and Faculty Work Room #333. All other rooms to receive manual shades.

2. **Statement:** Please provide a specification for intumescent fireproofing. It is noted in the drawings (general notes on sheet A6.0), but cannot be found in the specifications.

Response: Specification Section 07 81 23 "Intumescent Fireproofing" is enclosed.

3. **Statement:** Please verify the room numbers for the spec. 072129 sprayed insulation.

Response: This specification section applies to the project scope. Reference contract documents for exact locations.

4. **Statement:** On drawings A2.1, A2.2 and A2.3 note 11.01 calls for Ceiling Mounted Projector. Please provide a specification for these projectors.

Response: Projectors will be Owner provided, Contractor installed.

5. **Statement:** The window schedule on sheet A11.1 indicates the quantity of each window type, however I came up with different quantities for windows W3, W4, and W10. Please confirm the correct quantities:

- W3 = four (4) total units
- W4 = three (3) total units
- W10 = two (2) total units

Response: See Sheet A3.0 for window type locations. Totals indicated for the types questioned above are correct.

6. **Statement:** Sheet C6.1 does not clearly call-out/define any corresponding detail drawings associated with concrete curb and paving. This makes it difficult to determine where different curb & pavement types meet. Please provide enlarged details and/or cross sections to better define the scope of work.

Response: Additional notes have been added to Sheet C3.1 to identify curb and gutter and asphalt pavement locations. The pavement types on C6.1 are identified by hatching. Additional notes have been added to the details names on Sheet C6.3 to identify the fire lane pavement.

7. **Statement:** Drawing A5.0 calls out for 5-1/4" Lightweight Concrete Floor Slab Over 1-1/2" Deep Non-Composite Metal Deck. However, the S1.0 series of drawings, calls for 3-1/4" Lightweight Concrete (5-1/4" Total Thickness). Please clarify whether the Architectural Drawings or Structural Drawings are correct. Unless noted otherwise, F.H. Paschen will include only 3-1/4" of Lightweight Concrete over a 2" Metal Deck.

Response: Follow the Structural drawings (3 1/4" lt. weight concrete over 2" COMPOSITE metal deck) for deck design.
