ITEM NO. 2: REVISION TO: SECTION B. PART II. TECHNICAL COMPETENCE AND PAST PERFORMANCE: NON-PBC PROJECT DETAILS (Page 12 of 33)

1. Delete 1st Sentence of 1st Paragraph and replace with:

"Eligible Respondents must identify comparable public or private projects with construction costs of at least \$15,000,000.00 for SOUTHEAST AREA ELEMENTARY SCHOOL AND SOUTHWEST AREA SCHOOL and construction costs of more than \$5,000,000.00 for DUNNE TECHNOLOGY ACADEMY. For DUNNE TECHNOLOGY ACADEMY only, Respondent must identify projects within the last 5 years that were performed on a critical summer schedule."

ITEM NO. 3: REVISION TO: SECTION D. MBE/WBE, EEO AND COMMUNITY PARTICIPATION (Page 21 of 33)

1. Delete 2nd Sentence of 1st Paragraph and replace with:

"For Respondent's 3 most recent projects completed over the last 5 years where construction costs were at least \$15,000,000.00 (for Chicago Public Schools New Construction Projects), \$5,000,000.00 (for Chicago Public Schools Annex & Renovation Projects) and/or \$3,000,000.00 (for Abatement), Respondent must identify and report compliance history for each of the agencies listed below."
