ITEM NO. 5: REQUESTS FOR INFORMATION

- Question 1. Is there a specification or bid that is available for FFE items? If so, may the (Firm Name Intentionally Omitted) be placed on the bidder list?
- Response 1. Furniture, Fixtures, and Equipment are not included within this bid.
- Question 2. Please clarify what scope of work must be performed by City of Chicago licensed subcontractors.
- Response 2. Work at the modular building manufacturing plant must be performed by licensed trades. The modular building must comply with the City of Chicago code requirements. All construction work on the project site must be performed by respective trade contractors licensed with the City of Chicago.
- Question 3. Are the modular building manufacturing plant workers required to be Union workers?
- Response 3. Should the manufacturing of the modular buildings occur in the State of Illinois, workers are subject to the Chicago Board of Education Multi-Project Labor Agreement, dated June 2005. (Refer to Book 1, Section III. Instruction to Bidders, W. Project Labor Agreement) Should the manufacturing of the modular buildings occur outside of the State of Illinois, workers are subject to the local requirements of the jurisdiction where the work is being performed.
- Question 4. Are the modular building setting crew workers required to be Union workers?
- Response 4. Workers at the project site are subject to the Chicago Board of Education Multi-Project Labor Agreement, dated June 2005. (Refer to Book 1, Section III. Instruction to Bidders, W. Project Labor Agreement)
- Question 5. How will the modular building construction in the factory be inspected by the City of Chicago inspectors?
- Response 5. City of Chicago inspections are anticipated to occur through a combination of in person inspections within the factory and through the presentation of photographs to the City of Chicago Department of Buildings in order to verify that the work performed on the modular building meets the City of Chicago Building Code.
- Question 6.What are the anticipated Notice of Award and site access dates for this project?Response 6.Notice of Award is anticipated to be issued immediately following approval at the
May 12, 2015 PBC Board of Commissioners Meeting. Site Access is anticipated
1-3 days following the last day of the 2014-2015 school year. The PBC reserves
the right to change this timeframe if site access is granted prior to this date.
- Question 7. Underground Tank removal was not mentioned in new drawings, but the specifications call for one. Please clarify.
- Response 7. The PBC has no knowledge of an underground storage tank on the project site and has no reason to believe a tank exists on the site. The 02 65 00 Underground Storage Tank Removal specification section is included within the project documents in the chance that an Underground Storage Tank is discovered. Book 1 contains a Site Work Allowance Schedule that provides costs for the removal of underground storage tanks and associated materials.

- Question 8. It was stated at the pre-bid meeting that there are not any anticipated environmental concerns on this project. Could you please confirm that disposal of excess soils within property limits will be to CCDD facility?
- Response 8. The disposal of excess soils from within the property line will be disposed of at a CCDD site.
- Question 9. If the use of a CCDD site is confirmed, could you please clarify if PBC will provide LPC-662 or LPC-663 form, or if we are required to perform testing and obtain LPC-662/663 forms?
- Response 9. A LPC-662 form will be provided by the PBC to the successful bidder.
- Question 10. On similar projects with CCDD disposal requirements within property limits, the soil/fill disposal OUTSIDE of property limits is still required to be disposed of at Subtitle D facility. Could you please clarify if disposal of soil/fill outside property limits should be CCDD or Subtitle D?
- Response 10. Subtitle D disposal will be required for excavated materials outside the property limits.
- Question 10. Could you please confirm concrete walk base course is to be 4" depth FA-2 per detail 1 / C3.0?
- Response 10. Concrete Walk Base in the Public R.O.W. to be 4" FA-2 as shown in detail 1/C3.0. Concrete Walk Base on CPS property to be 8" CA-6.
- Question 11. Details 2 & 3 on C3.1 show geotextile fabric between CA-16 and CA-7 layers. Could you please clarify if fabric is only required ABOVE the CA-7, or if it will also be required underneath the CA-7 drainage layer?
- Response 11. Geotextile fabric to be provided both above and below the CA-7 layer.
- Question 12. Is area surrounding new playground to be sodded or mulched?
- Response 12. The area surrounding the new playground is to be sodded. See Addendum Drawing sheets for clarity.
