#### ITEM NO. 3: CLARIFICATION TO PROJECT NAME AND TITLE 1. None.

# ITEM NO. 4: REVISIONS TO BOOK 1

 Under Section 3. Instructions to Bidders, Local Business Subcontracting Participation, Community Hiring and Student Hiring, 3. Student Hiring DELETE the following paragraph: 'The Contractor agrees to participate in ... Acceptable activities for the Student Investment Program may include but not limited to:' and REPLACE WITH the following paragraph:

'The Contractor agrees to increase career awareness, help model student behavior through examples and reinforce in the student the link between classroom learning and work requirements. The ideal internship will integrate classroom learning with real world applications. A worksite supervisor needs to be assigned to review assignments, provide necessary training and submit a performance evaluation. Acceptable activities may include but not limited to:'

 Under Section 3. Instructions to Bidders, Local Business Subcontracting Participation, Community Hiring and Student Hiring, 3. Student Hiring DELETE the following paragraph: 'The Contractor agrees to... for the student at Substantial Completion (see Section C. Time of Completion):' and REPLACE WITH the following paragraph:

'The Contractor agrees to employ one (1) student intern for a minimum of 120 hours during the course of the Project. Ideally, the student intern should work from July 6, 2015 through August 21, 2015. The student intern shall be assigned to the Contractor by the Commission. Any

  - b. Delete "Division 21 Fire Suppression" and related four (4) specification sections (21 05 53, 21 11 00, 21 11 19 and 21 31 13).
- 2. Specification 01 23 00 FULL SCOPE AND LIMITED SCOPE
  - a. At Paragraph 1.4.A add the following item:

  - At Paragraph 1.4.D, add the following item: "2. Contractor shall be responsible to provide temporary power for the building in order to perform construction activities during power switchover by

## ITEM NO. 7: REVISIONS TO DRAWING SHEETS

- 1. SHEET A2.2.2 PARTITION DETAILS
  - a. Delete Details A8, A12, A16, E4, E8, E12 and E16 from sheet.
- 2. SHEET A1.3.3 ROOF DETAILS
  - a. At Detail J17, add the following note: "Extend wall flashing up wall to match existing flashing height".
- 3. SHEET E2.1.1 ELECTRICAL FIRST FLOOR NEW POWER AND LOW VOLTAGE PLAN
  - a. At Keynote #6 description, add the following sentence: "Remove existing wiring and pull new wiring at all existing electrical devices due to extension of electrical boxes."
- 4. SHEET E2.2.1 ELECTRICAL SECOND FLOOR NEW POWER AND LOW VOLTAGE PLAN
  - a. At Keynote #1 description, add the following sentence: "Remove existing wiring and pull new wiring at all existing electrical devices due to extension of electrical boxes."

# ITEM NO. 8: REQUESTS FOR INFORMATION

- Statement: Ceiling Upgrades the demo drawings indicate to remove the ceiling tiles [note D43]; however, if this (Alternate ADD) item is not selected then the tiles will be removed as part of the Limited Scope (Base Bid) but not re-installed. Please clarify.
  Response: Demolition of existing ceiling tiles shall be included as part of "Itemized Finish Scope", Item "A Ceiling Upgrades" (Specification Section 01 23 00 Full Scope and Limited Scope). However, existing ceilings that will be affected by "Limited Scope" work shall be included in "Limited Scope" scope of work.
- Statement: Furring of Existing Metal Wall Partitions the demo drawings indicate to remove the visual display boards [note 50]; however, if this (Alternate ADD) item is not selected there will be no visual display boards on the walls upon completion of the Limited Scope (Base Bid). Please clarify.

**Response:** Demolition scope to remove existing chalkboard/markerboard trays and tack strips (Keynote #D50), existing coat hooks (Keynote D68) and chalkboard / markerboard removal (Keynotes D65 and D66) from existing metal wall partitions where indicated on Sheet AD1.1.0 shall be included as part of "Itemized Finish Scope", Item "B – Furring of Existing Metal Wall Partitions" (Specification Section 01 23 00 – Full Scope and Limited Scope).

 Statement: Furring of Existing Metal Wall Partitions - should this (Alternate ADD) item not be selected the existing classroom and corridor walls will remain as is and not go up to the deck – please confirm that this is correct.
 Response: Existing corridor walls (metal wall partitions) shall not be required to be extended

to underside of floor/roof deck if "Itemized Finish Scope", Item "B – Furring of Existing Metal Wall Partitions" is not included in Contract Work.

- 4. Statement: Architectural Film Spec 012300 description indicates that "All finish work (signage, corner protection, etc.) shown on sheets A9.1.0 and A9.2.0 is to be included in this (Alternate ADD) item; therefore, if not selected signage, corner protection, etc. will not be installed upon completion of the Limited Scope (Base Bid). Please clarify. Response: Signage and corner protection indicated in documents shall be included in "Limited Scope" as indicated in "Itemized Finish Scope", Item "C Architectural Film" (Specification Section 01 23 00 Full Scope and Limited Scope).
- Statement: Floor Tile / Carpet Replacement Please clarify what new floor finishes are in the Limited Scope (Base Bid) and the Flooring (Alternate ADD).
   Response: All floor finishes that will be affected by "Limited Scope" work shall be included in "Limited Scope" scope of work.
- 6. Statement: The spec book includes some sections that do not appear to be relevant to Scope B (Expansion Joint Assemblies, Carpet Tile, Fire Suppression, and Earthwork) please clarify. Response: Specification Sections 07 95 13 Expansion Joint Assemblies and Division 21 Fire Suppression specification sections are to be deleted from bid specifications. Specification Sections 31 23 18 Soil, Fill and General Construction & Demolition Debris and 09 68 13 Carpet Tile are to remain in bid specifications as these sections relate to specified scope of work.
- 7. Statement: Is it possible to schedule another site visit preferably early next week? Response: No other site visits are scheduled for the work.
- 8. Statement: I was wondering if there was any interior/exterior signage with this project?

Response: Yes; refer to Sheets A9.1.0 and A9.2.0 for interior sign locations and Sheets A2.4.1 and A2.4.2 for related sign type details. Exterior signage is being provided under Scope 'A' contract.


9. Statement: Working overtime or more than the day shift will more than likely be necessary (particularly if the Finish Upgrades are done) to complete the Dunne Scope B by August 21. Can you clarify what work hours the Owner and the Alderman will allow at the site? Response: The PBC can negotiate with the Alderman for additional working hours as needed to complete the work by the GC.






Figure 2 - Work Limits (Narrative - Exits)




Figure 3 - Work Limits (Narrative - Utilities)




Figure 4 - Work Limits: NTP to June 26, 2015




Figure 5 - Work Limits: June 29, 2015 to August 21, 2015
