Clarification:

The Public Building Commission (PBC) seeks to meet and/or exceed the PBC's Minority and Women-Owned Business Enterprises (MBE/WBE) goals through the assignment of task orders to MBE/WBE prime consultants. Therefore, pre-qualified Consultants will not be required to subcontract a portion of an assigned task order to MBE nor WBE firms.

1. Delete Section V. Instructions for Preparing and Submitting Submissions – Item 5.3.3.7:

5.3.3.7 Minority and Women-Owned Business Enterprises. The Respondent is required to make a statement of understanding and commitment to comply with the Special Conditions Regarding the Utilization of Minority and Women Owned Business Enterprises as set forth in Attachment D on assigned task orders.

Replace with the following language:

5.3.3.7 Minority and Women-Owned Business Enterprises (MBE/WBE). Respondents who are currently certified as an MBE and/or WBE are to complete and submit Attachment H-Minority and Women Owned Business Enterprises Certification Report Form.

2. Delete Section VI. Evaluation Criteria - Item E - MBE/WBE UTILIZATION PLAN

The quality of the Respondent's statement of understanding and commitment to comply with the PBC's Special Conditions found in Attachment D as evidenced in the Executive Summary. In addition, The PBC will evaluate the Respondent's past performance in meeting and/or exceeding the MBE and WBE goals on PBC and Non-PBC projects as indicated in Attachment B.

Replace Section VI. Evaluation Criteria – Item E - MBE/WBE UTILIZATION PLAN with the following language:

The PBC will evaluate the Respondent's past performance in meeting and/or exceeding the MBE and WBE goals on PBC and Non-PBC projects as indicated in Attachment B.
