QUESTIONS & ANSWERS:

- Q1. Please confirm that the notes shown on PD1.1B with the prefix "D" refer to the notes on M0.1 with the prefix MD.
- **A1.** Confirmed. The notes on P1.0C, P1.1B, and PD1.1B will be changed to match M0.1 per addendum 4.
- Q2. Product, Model F80 projector and lens is specified in a bid for the Collin Hill High School. I wanted to advise that the F80 projector has been discontinued and replaced by the newer model, F82. The F82 is a brighter projector (10,000L) than the specified F80 projector (8500L). There was no increase in price. The new part numbers are:

F82, 10,000 Lumen, 3 chip DLP projector – 101-1611-08. Lens, 3.9-6.24:1 for the above projector – 503-0176-01

Is quoting the F82 and lens an appropriate response?

- **A2.** Yes, please quote the F82 and lens. The spec section will be updated per addendum 4.
- Q3. Question: Drawing 1 on A8.4 calls out motorized shades and points to two specific windows on the curtain wall. Is the intention for motorized shades only being provided at those two windows, or at the entire curtain wall?
- **A3.** The entire curtain wall. See A8.4 Detail 1 and Detail 2 (See change to Detail 1, addendum 4)
- **Q4.** 1 Sheet AB.01, General Note 20. Please clarify the extent of new materials subject to analytical testing. Surely you don't expect sample testing of *every* new material (eg., screws, drywall tape, etc.).
 - Addendum 2, Change 10.A and 11.A state to "See Change 12, A-E". Change 12 contains only A & B.

- **A4.** 1. All new materials except a material entirely composed of one or more of the following: metal, wood, fiberglass, foam or plastic. (eg. screws No, drywall tape Yes.)
 - 2. Change 11A and 12A should read "See Change 10, A-E"
- **Q5.** 1. A1.1B shows KN A10.1 in several locations on the drawing. However, A10.1 is not defined in the plan keynotes.
 - 2.A2.1B shows the projection screens in 140C and (1) screen in 140B to be 10'. An additional screen in 140B is shown as 8'. Drawing A8.4 shows all three of these screens to be 8'.
 - 3. Spec section 10522 FEC is included in the bid documents, but not shown on the drawings. Please indicate the number of fire extinguishers or FECs to provide.
- **A5.** 1. Keynote A10.1 should be "New Plumbing Fixture(s)"
 - 2. A2.1B should be followed. A8.4 will be revised to match as part of addendum 4.
 - 3. See FP1.1. FEC's will be coordinated with this sheet on A1.1B for addendum 4.
- Q6. 1. Division E2.1C Electrical Keynote 1 requires new light fixtures to be connected to existing circuits, but only if the load does not exceed 80% of the load of the circuit breaker. Please confirm that if after loads are measured and new feeders are required, that the cost of the new feeders can be charged to the Commissions Contingency Fund.
 - 2. E2.1C: The 5 new fixtures that are replacing the 5 demoed fixtures are not tagged with the electrical keynote. Please tag and provide keynote.
- **A6.** 1. Based on existing condition and field verification none of existing circuit exceeds 80% of the load. There should be no additional cost. Any scope changes, as determined by the AOR and Commission representative, will require an approved change order, as described in the general conditions.
 - 2. There is no key note required. F9 and F9EM light fixtures are new and shall be provided and installed as designed.
- Q7. Electrical Note 3 on Drawings ES1.1, E1.0A, E1.1A, E1.2A and E1.3A calls for replacing the conduit system if the existing cable cannot be removed. Electrical Key Note 1 states that we are to re-use existing conduit @ CCTV location being removed and replaced. Please advise if the cost to replace the conduit system can be charged to the Commission Contingency Fund since this is an unknown quantity at this time. If not, please confirm how we are to bid the project. Either re-use existing conduit or replace existing conduit. We cannot bid both ways.
- A7. Based on existing conditions and field verification, existing CCTV system has been recently installed with new raceways throughout. All defined CCTV upgrade costs shall be included in the base scope. Any required scope changes, as determined by the AOR and Commission representative, will require an approved change order, as described in the general conditions.
- **Q8.** 1. Drawings A13.1 & AD1.1B: Drawing AD1.1B shows terrazzo being demolished per note

AD2.20. However, Drawing A13.1 does not mark or note the terrazzo repair in most of the areas. Please advise.

2.Drawing A13.1 shows Rooms 134, 136, 148, 148A and 146 to have ceiling finish CL-2. However, there is no description or note for CL-2. Please advise.

3.Note CL-3 on Drawing A13.1 states gyp board soffit with dropped acoustical cloud. The specifications do not state what this "cloud" is. Please advise if this is just standard ACT.

- 1. A1.1, keynote 9.8 for locations of terrazzo repair. Refer to Plan Hatch Legend for areas of new construction (white represents new construction). See Change 8 Addendum 4 for added locations of keynote A9.8. On A13.1, all areas referenced fall under the note TERZ in the Material Key. See Change 9, Addendum 4 for added locations of the TERZ mark.
- 2. Rooms 148, 148A and 146 should be noted as CL-1. Rooms A134 and 136 should be noted as CL-3
- 3. ACT with high NRC
