The meeting was called to order by Chairman Rahm Emanuel and the presence of a quorum was established.

Following the roll call, a public participation period was conducted pursuant to Section 2.06(g) of the Open Meetings Act. George Blakemore, Mary Hartsfield and Dennis O'Neill had each previously registered to provide comments under the guidelines established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011. George Blakemore provided comments regarding the need for public officials to work together to correct the chronic problems facing the schools, police and pension systems and address the issues of crime and employment in the African American community. Mary Hartsfield expressed concerns regarding the corruption of public officials and employment of former convicts and homeless persons. Dennis O'Neill expressed appreciation for the work that Mayor Emanuel and Eugene Jones are doing to improve the Chicago Housing Authority especially in the Roosevelt Square area.

At the conclusion of the public participation period, Chairman Emanuel reconvened the meeting and presented to the Board of Commissioners for consideration of approval the minutes of the meeting held on May 10, 2016. The reading of said minutes, which had previously been distributed, was dispensed with and upon motion duly made and seconded, the minutes of the May 10, 2016 meeting were unanimously approved.

The next item on the agenda was consideration of approval of a resolution commending the service of Reverend Albert D. Tyson III as a Commissioner of the Public Building Commission. The Executive Director read for the record the following resolution:

### **RESOLUTION NO. 8293**

**WHEREAS**, on November 10, 2015, Reverend Albert D. Tyson III was appointed as a Commissioner of the Public Building Commission of Chicago and a member of the Administrative Operations Committee where he provided leadership to the Commission staff in his role on the Committee and distinguished himself as a member of the Board; and

**WHEREAS**, in addition to his volunteer service for the PBC Board, Reverend Tyson is the current Presiding Elder, North District, Chicago Annual Conference and served as a member of the Board of Trustees of the City Colleges of Chicago from 2000 until 2011; and

WHEREAS, Reverend Tyson's civic and community engagement has deep roots in Chicago. Reverend Tyson is currently a member of the Community Advisory Council of the Urban Health Program of the University of Illinois at Chicago; Chicago Branch Treasurer for the Congress of National Black Churches; Chairman of the Seventh Congressional District Clergy; Chicago Branch Chairman of the Minister's Division of the Rainbow/P.U.S.H. Coalition; and a member of the Operation P.U.S.H. Board of Directors. He has also been a board member of the Community Task Force at Malcolm X College, the Westside Health Authority, Henry Horner Boys & Girls Club, Bobby E. Wright Comprehensive Community Mental Health Center, The Women's Treatment Center, Chicago Theological Seminary, Interfaith Organizing Project, and the Near Westside Community Development Corporation. He is a Lifetime Member of the NAACP; and

WHEREAS, Reverend Tyson has served the parishioners of Saint Stephen African Methodist Episcopal Church from 1985 to 2011. In the past, he has been Assistant Minister to the Pisgah African Methodist Episcopal Church in Jersey City, New Jersey; Assistant Minister to the Ebenezer African Methodist Episcopal Church in Evanston, Illinois; and Pastor to the Saint James African Methodist Episcopal Church in Evanston, Illinois; and

**NOW, THEREFORE, BE IT RESOLVED**, that Reverend Tyson is hereby commended by the Chairman, members of the Board of Commissioners and the Executive Director of the Commission for his leadership and dedicated service to the Public Building Commission and the residents of the City of Chicago and Cook County; and

**BE IT FURTHER RESOLVED**, that the Executive Director is hereby authorized and directed to present an appropriate copy of this resolution to Reverend Tyson commemorating his service as a member of the Board of Commissioners of the Public Building Commission of Chicago.

The next item on the agenda was the nomination by Chairman Emanuel of Lindy F. Next, Commissioner Arnold Randall presented the report of the Administrative Operations (AO) Committee meeting held on June 2, 2016, which is summarized as follows:

1. Reports by the Chief Operating Officer. The AO Committee was advised by the Chief Operating Officer regarding the status of pre-qualification of General Contractor Classification Types B-E. She advised that 66 submittals were received in response to the Request for Qualifications (RFQ) and that PBC staff had evaluated each firm's submittals based upon technical competence and past performance, qualifications, financial capacity and other criteria. Based upon the evaluation, the Executive Director will provide a full report to the Board. The AO Committee accepted the report by the Chief Operating Officer.

### 2. Report by the Director of Construction.

The AO Committee also accepted the report by the Director of Construction regarding the following change orders:

• **Dunne Technology Academy Modernization (Scope A)** – change order in the amount of \$28,255.78 in order to revise the design of ADA ramp, including concrete, utility and excavation modifications associated with discovery of underground obstructions. Specifically, sanitary sewer and roof drain lines were discovered, requiring modifications to the foundations for the ADA ramp.

- **Lincoln Elementary School Annex** change order in the amount of \$114,973.00 for the Contractor to furnish and install moisture mitigation materials throughout the annex in areas scheduled to receive solid vinyl tile flooring in accordance with the manufacturer's recommendations and requirements.
- Payton College Prep High School Annex change order in the amount of \$584,958.00 due to enhancements to the flooring assembly in the 3<sup>rd</sup> floor gymnasium and weight/fitness room and includes the installation of a jack-up slab gym floor assembly.

The AO Committee was advised that 14 field orders were issued regarding the following projects: Southeast Area Elementary School; Southwest Area School; Payton High School Annex; Canty Elementary School Annex; Jamieson Elementary School Annex; and Edwards Elementary School Annex & Renovation.

The Board of Commissioners was next presented with a report entitled, "Notice of Awards on contracts not in excess of \$25,000". There was one item listed on the report attached to the board materials. The report was accepted and a copy of this report is attached hereto as Exhibit "B".

The next item on the agenda was consideration of approval of the pre-qualification of General Contractor Classification Types B-E based upon project size limits in the following categories: A - No Limit; B - Greater than \$10 million; C - Greater than \$5 million; D -Greater than \$2 million; and E – Greater than \$500,000. The Executive Director advised the Commissioners that this initiative is designed to promote contractor capacity building for completion of smaller facility renovations and/or site improvement projects by providing opportunities for small contracting firms to enter into contracts as general contractors with the Public Building Commission. Outreach efforts by the Public Building Commission to encourage small firms to participate included communications with all 50 aldermanic offices, assist agencies, social media, e-mail alert service, Operation Push, HACIA, African American Contractors Association. In addition, a Pre-submission Conference and two Contractor Workshops were at the Renaissance Collaborative and a Contractor Workshop held over two days that were attended by 186 persons representing 132 different firms. As a result of the outreach efforts 66 responses were submitted in response to the Request for Qualifications (RFQ). Submissions were evaluated by an Evaluation Committee on the basis of technical competence/past performance, qualifications and relevant experience of Key Personnel, and the firm's financial capacity. Upon recommendation by the Executive Director, and on motion duly made and seconded, the Board of Commissioners approved the pre-qualification of General Contractor Classification Types B-E as follows:
