The next item on the agenda was a report by Commissioner Randall regarding the Administrative Operations (AO) Committee meeting held on December 1, 2016 summarized as follows:

The AO Committee heard the following recommendations and reports from the Chief of Staff.

- A report on the bid opening for Contract No. 1574 recommending Robe, Inc. as the general contractor for the Exterior Lighting and Anthony Wing Decommissioning Project at Chicago Vocational Career Academy.
- A specialty consultant task order issued to Terracon Consultants, Inc. for environmental renovation and demolition services at Chicago Vocational Career Academy in the sum of \$41,433.70.

A summary of the foregoing Specialty Consultant Task Order is attached hereto as

Exhibit A.

The AO Committee heard the following recommendations from the Director of Procurement.

- A recommendation to approve amendments to term agreements with GHFX
 Digital Imaging, Chicago Print Group, Cross Rhodes Reprographics and Cushing
 & Company for Digital Construction Printing Services. These amendments
 exercise the second one-year extension option with no added dollar value.
- A recommendation to approve amendments to term agreements with The Blue Print Shoppe, Impact Signs and Sign A Rama for fabrication and installation of signage at PBC construction sites in the sum of \$10,000 per contractor. These amendments exercise the second one-year extension option.
- A recommendation to approve an amendment to Vigilant Solutions for license plate recognition and database management services for the OEMC Camera Program in the sum of \$250,000. This amendment exercises a one-year extension option.
- A recommendation to approve an amendment to Motorola, Inc. for OEMC System Integration and Installation services. This amendment exercises the second one-year extension option.
- A recommendation to approve an amendment to RICOH for copier services. This amendment authorizes the PBC to continue utilizing the buying power for the US Communities government co-operative to lease and maintain copy machines. The term of the agreement authorizes services not-to-exceed \$220,000 through December 31, 2019.
- A recommendation to approve an amendment for Zayo/Latisys for third party data hosting services for a sum not to exceed \$20,500. This amendment exercises the second one-year extension option.

- A recommendation to approve an amendment for Cogent Communications for Data Disaster Recovery for a sum not to exceed \$18,600. This amendment exercises the second one-year extension option.
- A recommendation to approve an amendment for McLaren Collaboration Workspace (CW) for document management and business process systems services in the sum of \$206,400. This amendment is a two-year extension of the existing contract.
- A recommendation to approve an amendment for MB Real Estate Services, LLC for property management services at the Richard J. Daley Center in the sum of \$188,533. This amendment exercises the second one-year extension option for property management services.

The AO Committee heard the following recommendation from the Director of Construction.

• A recommendation to approve a change order for the Wildwood World Magnet School Faculty Room Renovation and Intercom Repair Project. The change includes a credit in the sum of \$21,818.41 to deduct unused allowance and contingency.

Following the report by the Administrative Operation Committee, a public participation period which was listed on the agenda as Item A2 was conducted pursuant to Section 2.06(g) of the Open Meetings Act. George Blakemore had previously registered to provide comments under the guidelines established by Resolution No. 7611 approved by the Board of Commissioners on January 11, 2011. George Blakemore acknowledged the willingness of the Public Building Commission to allow him to speak following the public participation period specified on the agenda. He provided comments regarding the newly-elected president of the United States, the City of Chicago as a sanctuary city, the decrease in the African American population in Chicago and the need to support Mayor Emanuel in eliminating urban problems.

Next, the Executive Director provided a Notice of Awards report of Contracts \$25,000 and under. She advised the Commissioners that there was one contract under \$25,000 that had been awarded since the prior report. The Executive Director's Notice of Awards report was accepted and a copy is attached hereto as **EXHIBIT D**.

The next item on the agenda was a report by the Executive Director regarding regular reports, development status and other matters. The Executive Director advised the Commissioners regarding efforts to ensure PBC's fiscal solvency by creating new revenue sources. One initiative undertaken is the expanded use of the Richard J. Daley Center in ways that will create additional revenue and defray a portion of the costs of administration, operation and maintenance of the facility. As previously discussed during the Annual Board Meeting, the current Amended Regulations and RJDC Guidelines have restricted using the premises for commercial activities. In collaboration with Legal Counsel, Neal & Leroy, resolution was proposed authorizing the expanded use of the premises to allow private, corporate and commemorative uses to be conducted including the sale or consumption of alcoholic beverages. In addition, the proposed resolution authorizes the use of the concourse level, non-occupied spaces and court rooms to be used for private, corporate and commemorative events and activities. Further the resolution authorizes the Executive Director to take appropriate actions to establish a fee structure, market the expanded activities and events to prospective users and work with the Property Manager to establish appropriate rules and regulations with regard to the expanded use of the Daley Center. Following the acceptance of the Executive Director's report, the following resolution was adopted:

RESOLUTION NO. 8339

WHEREAS, in *Grutzmacher v. Public Building Commission of Chicago*, No. 87 C 10746, it was determined by the United States District Court for the Northern District of Illinois that the Richard J. Daley Center ("RJDC") Plaza is a traditional public forum entitled to the protection of the First Amendment of the United States Constitution and must be governed, as to time, place, manner and duration of use, in accordance with principles of First Amendment jurisprudence; and

WHEREAS, the Board of Commissioners ("Board") of the Public Building Commission of Chicago ("PBC") has heretofore adopted Amended and Restated Regulations and Procedures (the "Amended Regulations"), as amended from time to time, Governing the Use of the Lobby and Plaza of the Richard J.

Daley Center (collectively, the Lobby and the Plaza of the RJDC are referred to herein as the "Premises"), and

WHEREAS, PBC acting through its Property Manager, has adopted procedural guidelines (the "RJDC Guidelines") that must be followed by individuals and groups seeking to obtain permits in order to conduct an event or activity, or to erect a display, exhibit or structure on the Premises, and providing for the payment of costs and fees for the use of the Premises; and

WHEREAS, heretofore the Amended Regulations and RJDC Guidelines have restricted the use of the Premises by requiring that uses or activities involving the sale or promotion of goods or services, including food or beverages, in connection with any commercial activity undertaken primarily for the benefit or profit of an individual or group within the Lobby or the Plaza to be sponsored by PBC or an Authorized Lessee (i.e., the County of Cook or the City of Chicago); and

WHEREAS, the Board is committed to increasing the revenues generated by activities and events conducted at the RJDC to defray a portion of the costs of administration, operation and maintenance of the RJDC and to reducing the costs that must be borne by the taxpayers as a result of such activities in a manner consistent with principles of First Amendment jurisprudence consistent with the provisions of this Resolution; and

WHEREAS, it has been proposed that the Board authorize the expanded use of the Premises to permit private, corporate and commemorative uses to be conducted at the RJDC, including without limitation commercial events and activities involving the sale or promotion of goods or services or the consumption of alcoholic beverages, in order to generate additional revenues that would be used to defray a portion of the administrative, maintenance and operating costs of the RJDC; and

WHEREAS, it has been further proposed that the Board authorize the use of additional portions of the RJDC that include, without limitation, the concourse level, 27th Floor and court room spaces for private, corporate and commemorative events and activities so long as such use does not interfere with activities and events by the Authorized Lessees and are approved by the PBC acting through its Property Manager as a means of obtaining additional revenue to defray expenses incurred to operate, maintain and administer the RJDC; and

WHEREAS, pursuant to Section 14 of the Public Building Commission Act of the State of Illinois, 50 ILCS 20 et. seq.), PBC has the express and incidental powers necessary to carry out its statutory powers and essential governmental functions including the authority "to operate, maintain and manage . . . its building and facilities" including RJDC, upon such terms and in such manner as the Board shall determine; and

WHEREAS, the Board may authorize the Executive Director to approve all necessary procedural guidelines, policies, rules and regulations providing for the expanded use of the RJDC for the conduct of activities and events, and the display of exhibits or structures by individuals and groups, including commercial users or vendors, subject to principles of First Amendment jurisprudence.

THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Public Building Commission of Chicago as follows:

- 1. The foregoing recitals are hereby incorporated herein by reference.
- 2. The Board of Commissioners hereby authorizes and approves the expanded uses of RJDC to include private, corporate and commemorative uses including, without limitation, commercial events and activities involving the sale or promotion of goods or services and the sale or consumption of alcoholic beverages, as a means of generating additional revenues for the administration, operation and maintenance of the RJDC.
- 3. The Executive Director is hereby authorized and directed to take such action as may be necessary and appropriate in order to implement this Resolution providing for the expanded uses of the RJDC including, without limitation, promulgation of rules and regulations with regard to the requirements of this Resolution, approval of an appropriate fee structure for permitted events and activities, directing the Property Manager to undertake appropriate activities to obtain prospective users, and advising prospective users of the expanded activities and events which may be held at the RJDC through appropriate outreach efforts by PBC and its Property Manager.
 - 4. This Resolution shall take effect immediately upon its adoption.

Finally, the Executive Director congratulated Commissioner Arnold Randall and the Forest Preserves of Cook County on their Centennial Anniversary and the reception of an Emmy Award for their documentary, "Chicago's True Nature: The Forest Preserves of Cook County". She then read the following resolution into the record:

RESOLUTION NO. 8340

A Public Building Commission of Chicago resolution congratulating Commissioner Arnold Randall and the Forest Preserves of Cook County on their Centennial Anniversary and the reception of an Emmy Award for their documentary, "Chicago's True Nature: The Forest Preserves of Cook County."

WHEREAS, the Forest Preserves of Cook County, set aside by visionaries beginning in 1913 and covering more than 69,000 acres today, is the largest forest preserve district in the United States; and

WHEREAS, the Forest Preserves of Cook County is among the most geologically and biologically rich natural areas in the United States, with wetlands, tallgrass prairies, oak woodlands, savannas and more, all of which provide refuge to an abundance of wildlife, including numerous threatened and endangered species; and

WHEREAS, the Forest Preserves of Cook County receives an estimated 40 million visits each year, providing an escape into a world teeming with wildlife, rich outdoor recreation and environmental education opportunities; and

WHEREAS, the Forest Preserves of Cook County provides environmental and health benefits to Cook County residents and creates stronger communities; and

WHEREAS, the Forest Preserves of Cook County celebrated its centennial anniversary by creating an new vision for the continued preservation of the Forest Preserves as well as initiatives to get more Cook County residents engaged with nature; and

WHEREAS, the Forest Preserves of Cook County won an Emmy Award for its hour-long documentary that captures the sights and sounds within the Forest Preserves, allowing audiences to see and learn about the benefits of nature, the impact of open land to our quality of life, and what lies ahead in the next century for one of the oldest and largest forest preserve systems in the nation;

NOW THEREFORE, BE IT RESOLVED by the Public Building Commission of Chicago that Commissioner Arnold Randall and the Forest Preserves of Cook County are congratulated not only on their Centennial Anniversary and reception of an Emmy Award for their documentary, but also for their initiatives to preserve the vast biodiversity of flora and fauna in the urban preserves.

BE IT FURTHER RESOLVED, that the Public Building Commission of Chicago commends Commissioner Arnold Randall and the Forest Preserves of Cook County for their conservation and research initiatives, educational programs, volunteer efforts and wide variety of recreational activities that can be enjoyed right here in Cook County.

WHEREAS, as a part of its bid proposal, Robe, Inc. has advised the Commission that the surety on the performance and payment bond to be supplied in the form set forth in the contract documents will be Employers' Mutual Casualty Company, a corporate surety authorized to do business under the laws of the State of Illinois; and

WHEREAS, the staff of the Commission has recommended that Contract No. 1574 be awarded to Robe, Inc. and Employers' Mutual Casualty Company, proposed surety on the performance and payment bond, be accepted and approved by the Commission.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners hereby awards to Robe, Inc. BE IT FURTHER RESOLVED that the Public Building Commission of Chicago does hereby approve a payment and performance bond to be supplied in the form set forth in the contract documents comprising Contract No. 1574, subject to the completion and delivery to the Commission of said form of bond by Robe, Inc. and Employers' Mutual Casualty Company, as surety, in the principal amount of \$742,476.80, and the Chairman is hereby authorized and directed to signify approval by the Commission of the fully executed bond.
